
Curtis Stonestreet Superintendent

This project was the 7,620 SF renovation of the second half of the same existing warehouse facility.

March 2020 brought an unprecedented challenge to the entire world, the outbreak of COVID-19 which was deemed a global pandemic. On March 23, Governor Larry Hogan issued an executive order closing all non-essential businesses. As an essential business as noted in the Interpretive Guidance issued by Office of Legal Counsel, NARDI took immediate action to continue operations while also protecting our employees, subcontractors and their employees. NARDI closed our main office to the public effective close of business on March 23. We encouraged our employees to work remotely as much as feasible and to utilize social distancing practices such as conference calls in lieu of normally scheduled progress meetings. To protect our jobsites, NARDI ordered and posted Coronavirus (COVID-19) Facts Posters on all of our active jobsites and distributed toolbox safety talks, OSHA and CDC guidance for our superintendents to share with jobsite personnel.

Administration Building

To date, NARDI has completed four phases of work at the Wayne K. Curry (KFC) Administration Building for Prince George's County. Phase I - demolition, Phase II - RTU Replacement, Phase III - CEX office, Phase IV - 1st floor finance. Next up, is the first floor Hearing Room renovation which is in the pricing stage.
