### County Mentor Protégé Program

The local business development program aims to enhance the capabilities of County-based small and County-based minority businesses ("protégé firms") through formal agreements with large businesses ("mentor firms") for the purpose of improving the protégé's ability over time to successfully compete for contracting opportunities at the prime level.

# NEWLY COMPLETED PROJECT: Prince George's County Circuit Court Security Checkpoint



NARDI completed construction of the Security Checkpoint at the Prince George's County Circuit Court in September 2021. The official ribbon cutting ceremony took place on September 22. The construction of the vehicle security checkpoint included exterior excavation and demo, roadway widening and resurfacing, concrete and barriers, guard booth, canopy, electrical and lighting, landscaping, storm drain improvements, signage and striping, along with the installation of a SWM bioswale facility.

# NEWLY AWARDED PROJECT: Canine & EVOC Training Facilities



NARDI received the official NTP awarding the Prince George's County's Canine and Emergency Vehicle Operations Course facilities project in August 2021. This project involves the expansion of the existing Public Safety Training Complex by adding a state-of-the-art Canine facility, accompanied with an Emergency Vehicle Operations Course. The 1 story 10,308 SF canine training facility will provide program support space and house 12 canines. The 1 story EVOC facility will manage the operations course, which will feature a mile-long driving track, skills pad, and a slow skills pad.



# PROJECT IN PROGRESS: Department of Corrections Medical Unit Building

NARDI has entered the 8th month of construction of the new medical unit at the Prince George's County Department of Corrections. Vapor barrier has been completed and masonry work, plumbing and ductwork installation are underway. The new 22,263 SF 2 story facility will include exam rooms, isolation cells, medical treatment areas, upgraded security, medical offices, and a full vegetative roof.
